

## FHC iPad ACCEPTABLE USE AGREEMENT

The use of the FHC iPad technology resources is a privilege, not a right. This policy is provided to make all users aware of the responsibilities associated with signing out an iPad. If a person violates any of the User Terms and Conditions named in this policy, privileges may be ended.

Students in good standing are allowed to sign out an available iPad from the library if this user agreement is signed and returned to the school administration.

### Parent/Guardian Responsibilities

- Talk to your children about values and the standards that your children should follow on the use of the iPad just as you do on the use of all media information sources such as television, cellphones, and radio.

### School Responsibilities are to:

- Provide Internet access to its students.
- Provide guidance to aid students in use of the device and help assure student compliance of the acceptable use policy.

### Students are Responsible For:

- Obeying general school rules concerning behavior and communication that apply to iPad/computer use.
- Using all technology resources in an appropriate manner so as to not damage school equipment.
- Students should always secure their iPad after they are done working to protect their work, information and device.
- Any data left on the iPad when the device is returned.
- Demonstrating the iPad is not damaged and operates as intended upon return.

### Student Activities Strictly Prohibited:

- Any action that violates existing school policy or public law
- Changing of iPad settings (exceptions include personal settings such as font size, brightness, etc.)
- Not removing or installing an app(s) on the iPad.
- Vandalism (any malicious attempt to harm or destroy hardware, software or data) of school equipment will not be allowed

### Student Pledge for iPad Use

- I will take good care of the iPad.
- I will never leave the iPad unattended.
- I will never loan out my iPad to other individuals.
- I will keep food and beverages away from my iPad since they may cause damage to the device.
- I will not disassemble any part of my iPad or attempt any repairs.
- I will protect my iPad by only carrying it while in the case provided.
- I will not place decorations (such as stickers, markers, etc.) on the iPad or deface the iPad.
- I understand that my iPad is subject to inspection and remains the property of the school.
- I will be responsible for all damage or loss caused by neglect or abuse.
- I agree to return the iPad in good working condition.
- I will notify school officials immediately in case of theft or vandalism.

**-I am responsible for the iPad device even if stolen, lost or misplaced while signed out.**

**-If I lose, damage or fail to return the iPad device to the school library I understand that I am responsible to reimburse the school the cost to repair or replace the iPad up to a cost of \$500.00.**

**-Violation of the user agreement may result in suspension of the user's privilege to sign out iPads in the future. I agree to the stipulations set forth in the above document.**
